Assignment 1 Read and Annotate Required Text – 20 points total- completion

How to Read Literature Like a Professor by Thomas C. Foster

Read Thomas C. Foster's *How to Read Literature Like a Professor*. As you read, write a *one-sentence* summary of each chapter, illustrating Foster's main point for that chapter. This will become a study guide you'll be able to use all year when we read works together.

- **Annotations: Annotate 3 texts** -30 points total - completion
- **In-Class Essays: Write 1 for each novel** -150 points total - graded according to rubric below

Great Expectations Charles Dickens

Read and Annotate Your Choice of ONE additional text from the list below

Purple Hibiscus Chimamanda Ngozi Adichie

Read and annotate **all THREE** novels. As you annotate, consider the themes below. Your annotations for these themes will help you prepare for the in-class essays you will write about each of the three novels when you return to school. Annotations may be in-text or on paper. They must demonstrate your ability to connect elements of literature with the themes below.

During the first two weeks of school. You will write three in-class essays. You will pair one novel with one theme and write an in-class essay discussing how the author uses literary elements to support a theme/message. You must write about all three novels, and you must write about all three themes. You must decide which novel best exemplifies each theme.

Themes for Consideration:

The Past

How does a person's past influence his or her thoughts, opinions, and/or actions in the present? Annotate your novel to show how one or more characters contend with aspects of the past.

Internal Conflict

What causes internal conflict? Look for ways in which characters feel torn between two compelling desires, obligations, or influences.

Deception/Betrayal

How do deception and/or betrayal function in the novel? Annotate your novel to show who deceives or betrays whom and why. Note how and why the deception or betrayal impacts others.

Assignment 3 Application and Analysis Paragraphs (25 points – completion)

Choose at least five (5) chapters from Thomas C. Foster's book and apply them to ONE of the novels you selected. For each of the five selected points in Foster's book, choose a corresponding passage from your novel that demonstrates it, and write a paragraph explanation of how the author uses a technique for a purpose. Be sure to include apt text references (quotes) to support your ideas, and use proper MLA format for citations. This assignment must be typed and submitted on paper (MLA format) on the first day of class.

Assignment 4 College Essay (50 points – completion)

Select one of the 2019 Common Application prompts and craft a well-written 500-700 word response. Bring your typed essay to class and submit it on paper (MLA format) on the first day of school. Save a digital copy to share with Dr. Tolentino during the first week of school.

During the first two weeks of school, Dr. Tolentino will help you revise your college essays and prepare them for submission. You will engage in writing workshops during class, and you will schedule individualized writing conferences with Dr. Tolentino during lunch and/or before or after school.

College Board Score	Grade	Explanation
9-8	100-94	These well-written essays clearly demonstrate an understanding of the topic and have chosen an appropriate work of literature and appropriate element(s) (character, theme, tone, plot device, etc.) within that work. They address the topic convincingly with apt references. Superior papers will be specific in their references, cogent in their explications, and free of plot summary that is not relevant to the topic. These essays need not be without flaw, but they must demonstrate the writer's ability to discuss a literary work with insight and understanding and to control a wide range of the elements of effective composition.
7-6	90-86	These essays also choose a suitable work of literature and analyze the appropriate elements. These papers, however, are less thorough, less perceptive or less specific than that of 9-8 papers. Though they are not as convincing in their discussion, these essays are generally well-written; however, they have less maturity and control than the top papers. They demonstrate the writer's ability to analyze a literary work, but they reveal a less sophisticated analysis and less consistent command of the elements of effective writing than essays scored in the 9-8 range.

5	81	Superficiality characterizes these essays. They choose an appropriate element from a suitable work, but the explanation is vague or over-simplified. The discussion may be pedestrian, mechanical, or inadequately related to the topic. Typically, these essays reveal simplistic thinking and/or immature writing. They usually demonstrate inconsistent control over the elements of college-level composition and are not as well conceived, organized, or developed as the upper-half papers; the writing, however, is sufficient to convey the writer's ideas.
4-3	75-60	These lower-half papers may not have chosen an appropriate element or suitable text, or they may have failed to address the topic. Their analysis may be unpersuasive, perfunctory, underdeveloped, or misguided. Their discussion may be inaccurate or not clearly related to the chosen element. The writing may convey the writer's ideas, but it reveals weak control over such elements as diction, organization, syntax, and grammar. These essays may contain significant misinterpretations of the text, inadequate supporting evidence, and/or paraphrase and plot summary rather than analysis.
2-1	55-50	These essays compound the weakness of essays in the 4-3 range. They seriously misread or fail to comprehend the novel or the play (or the question itself), choose an inappropriate element, or seriously misinterpret the topic or the function of the element in the work they have chosen. In addition, they are poorly written on several counts, including many distracting errors in grammar and mechanics, or they are unacceptably brief. Although the writer may have made some effort to answer the question, the argument presented has little clarity or coherence. Essays that are especially vacuous, ill-organized, illogically argued and/or mechanically unsound should be scored 1.
0	0	This is a response with no more than a reference to the task, a blank response, or one that is unrelated to the assignment.
